

The Carmichael Endowment

Pearl and Don Carmichael were longtime Hinton residents who bequeathed money to be used to provide bursaries for Harry Collinge High School University bound students. The Carmichaels were interested in helping students who might not otherwise attend university due to the cost.

The amount of the award varies yearly according to interest earned on the principle amount. The Harry Collinge High School Awards Committee determines the amount and number of awards each year based on the fund's previous year's earnings. The Carmichaels intended that the amount awarded would offset approximately one year's tuition and books in a university or university transfer program.

The Carmichael Endowment Scholarships are available for HCHS Graduates entering the first year of full time university or university-transfer studies within 12 months of graduation from HCHS. The essence of the will is that the money is to go to students with the greatest financial need.

In order for your application to be considered, you must include the following:

1. **A completed application form.**
2. **An essay.**

Your essay should not exceed one page. It will be word-processed, single-spaced in 12 point font. All margins are one inch. Please address the following topics:

Financial Need	The Carmichael scholarship is awarded primarily on the basis of financial need; therefore to be considered for this scholarship you must clarify your need for financial support.
School / Community Involvement/Part-time work/Volunteer work	student union, sports, band, any other involvement in the community, number of hours a week you have been working, etc.
Future Plans	Provide details about your future educational plans and life goals.

3. **Mark transcripts.**

- an **Academic Transcript** (from the Guidance Office)
- a **Semester 2 Report card** signed by the principal or a counselor
